- 1. Upon receipt of the Order Form from the client, DNS Enterprises will contact you with the request to supply all text/information/photos/logos and branding colours to be used.
- 2. DNS Enterprises prepares a concept design dummy based on materials supplied in step one.
- 3. The client is notified, and a process of reciprocal information flow follows to get the concept design and layout of the template as per the client's specifications. The first step is to get the concept design and layout finalized before continuing with the rest of the website. Only 1 page is presented to the client as a concept design draft.
- 4. It is important that the client provides DNS Enterprises with as much information as possible about colour schemes and layout.
- 5. Once the client has given final written approval of the concept design and layout, the rest of the website is finalised by including the correct text, photographs, and graphics as supplied by the client.
